Sponsorship Application

This application is for all potential sponsors.

Sponsors who wish to exhibit products at the Seattle Cheese Festival must be of high quality and must be cheese related. Preference is given to artisanal cheese products. Festival management will strive to maintain a strong focus on artisanal cheese and as a result, less than ten percent of the show sponsors or exhibitors will be offering cheese condiments, bread/crackers or other similarly associated products.

Applicants are required to include a list of the products they intend to sample and/or sell at the Seattle Cheese Festival. Festival Management reserves the right to reject the application based on quality or appropriateness to the Festival. Management reserves the right to insist sponsors and exhibitors remove any unauthorized or inappropriate products during the Festival.

Types of Exhibit Space

- Tent Canopy Aisle – Open to pedestrian walkway on one side. Fabric draping and/or signage encloses the back.
Tent Canopy Corner – Open to pedestrian walkway on two sides. Fabric draping and/or signage is at the back and one side of the space is adjacent to another vendor.
- High Stall Table – One approximately 96”x 30” table, set up on the street side of the Pike Place Market High Stalls. The table will be positioned under an awning. Open to pedestrian walkway on one side.

Regulations

- Exhibitors must staff their booths at all times during the event hours.
- Exhibitors must abide by the rules and regulations regarding the sale and sample of products at the Pike Place Market.
- Exhibitors must provide proof of liability insurance to cover all activities relating to the event. The insurance must be with a reputable insurance company satisfactory to the Seattle Cheese Festival in the minimum amount of One Million Dollars (\$1,000,000) for property damage and Two Million Dollars (\$2,000,000) per accident and shall name the Seattle Cheese Festival as an additional insured. Documentation of such coverage will be made available to the Seattle Cheese Festival prior to the sponsor commencing any activities at the event.

Payments

- Applications are due by February 28, 2010
- The sponsorship fee must be paid in full by March 28, 2010
- Cancellation Policy for Sponsors: Cancellation before March 28, 2010 for sponsorship is subject to a fee equal to 25% of the sponsorship fee. For any cancellations made after March 28, 2010, no refunds will be made.
- The receipt of the Sponsorship Application does not constitute acceptance in the festival.
